- e) you agree that clause 3. sets out a complete statement of our obligations to you under the terms of this licence, that we disclaim any and all other warranties, undertakings or representations, and that in any event our liability to you under the terms of this licence will be limited to the Licence Fee payable by you.
- f) you indemnify us and shall at all times keep us indemnified against all actions, proceeds, costs, claims and damages whatsoever incurred by or awarded against us and compensation agreed by us in consequence of any breach or non-performance by you of any of the warranties and undertakings in this licence.

# 5. CREDIT
